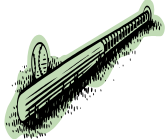


_____ **Representation or Legal Guardian**

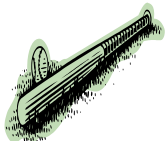
_____ **Photo/Video Release**

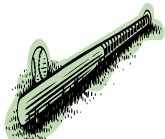


Release of Liability:

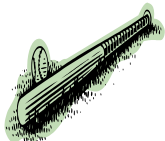

This release is intended to discharge in advance the Boys & Girls Club (its officers, employees, and agents) from and against any and all liability arising out of or connected in any way with my participation in said activity, even though that liability may arise out of negligence or carelessness on the part of Boys & Girls Club (its officers, employees, or agents).



I understand that T-Ball may be of hazardous nature and/or include physical and/or strenuous exercise or activity; that serious accidents occasionally occur during the above activity; and that participants in the above activity occasionally sustain mortal or personal injuries and/or property damages as a consequence thereof. Knowing the risks involved, nevertheless, I have voluntarily applied to participate in said activity and I hereby agree to assume any and all risks of injury or death and to release and hold harmless the Boys & Girls Club of the Redwoods (its officers, employees, and agents) who through negligence, carelessness, or any other act or omission might otherwise be liable to me.
