**Release of Liability:**

In consideration for being permitted by the Boys & Girls Club of the Redwoods to participate in T-Ball, I hereby waive, release, and discharge any and all claims for damages for personal injury, death, or property damage which I have or which may hereafter accrue as a result of my participation in said activity. This release is intended to discharge in advance the Boys & Girls Club (its officers, employees, and agents) from and against any and all liability arising out of or connected in any way with my participation in said activity, even though that liability may arise out of negligence or carelessness on the part of Boys & Girls Club (its officers, employees, or agents).

I understand that T-Ball may be of hazardous nature and/or include physical and/or strenuous exercise or activity; that serious accidents occasionally occur during the above activity; and that participants in the above activity occasionally sustain mortal or personal injuries and/or property damages as a consequence thereof. Knowing the risks involved, nevertheless, I have voluntarily applied to participate in said activity and I hereby agree to assume any and all risks of injury or death and to release and hold harmless the Boys & Girls Club of the Redwoods (its officers, employees, and agents) who through negligence, carelessness, or any other act or omission might otherwise be liable to me. I further understand and agree that this waiver, release, and assumption of risks are to be binding on my heirs and assigns.

I further agree to indemnify and to hold the Boys & Girls Club of the Redwoods (its officers, employees and agents) free and harmless from any loss, liability, damage, cost, or expense which they may incur as a result of any injury and/or property damage that I may sustain while participating in T-Ball.
